#### II. SECRETARY'S REPORT

### III. TREASURER'S REPORT

# A. Quarterly Treasurer's Report

The total number of new and reinstated members proposed for the October 26, 2022, Board Meeting is twenty six (26), comprised of two (2) Proctors, eighteen (18) Associates, one (1) Academic, five (5) Reinstatements. Four (4) Law Students were also approved since the July 2022 meeting.

Mr. Giles also reported that of the total Membership, 644 are Life Members.

ON MOTION DULY MADE AND SECONDED, the Board unanimously approved the Membership Secretary's Report.

### V. WEBSITE AND TECHNOLOGY SECRETARY'S REPORT

Website and Technology Secretary Krieger reported that the Association has begun the process of migrating the Association's database to a more robust platform using software recommended by *Group Concepts*. Ms. Krieger estimated that the migration would likely be completed by early 2023.

ON MOTION DULY MADE AND SECONDED, the Board unanimously approved the Website and Technology Secretary's Report.

# VI. BOARD COMMITTEE REPORTS, UPDATES

## A. Policy for Posting Notices on Association's Website

First Vice President Hurley reported on the need for a written policy regarding posting of notices by Members on the Association's Website and *LinkedIn* page, and he requested that the Board of Directors create an *ad hoc* committee to address the issue. Board members were asked to advise Mr. Hurley if they were interested in serving on the committee.

# B. 125th Anniversary of the Maritime Law Association

First Vice President Hurley addressed plans for the 125<sup>th</sup> Anniversary celebration in 2024, including venue options for the Fall meeting. Currently, Washington DC is the preferred venue for the Fall meeting, which is tentatively planned for October of 2024.

## C. Board Liaisons to Standing Committees

Second Vice President Moseley emphasized the need for Board liaisons to the Standing Committees to actively communicate with their Committee Chairs and report to Mr. Moseley regarding Committee Chairs' compliance with their respective duties and responsibilities.

#### VII. DISCUSSION TOPICS

President Holland reported on the ongoing transition of duties and responsibilities from the Association's long-time Administrator, Robin Becker to *Group Concepts*, and the planned retirement of Ms. Becker on December 31, 2022.

President Holland reported that discussions continue regarding potential interest in an online MLA report or posting of notable court decisions on the Association's website. Further discussions await the completion of the website migration.

President Holland led a discussion on efforts to recruit new members. Various suggestions were proposed including Board members hosting regional recruiting events, promotional materials in the leadup to the Association's 125<sup>th</sup> anniversary to include emphasis on CLE, as well as speaking and publishing opportunities for young lawyers.

Immediate Past President Farrell reported on continuing efforts by the Association to advocate for adoption of the Rotterdam Rules by the United States. Due to the pressing concerns of the U.S. State Department regarding the War in Ukraine, however, there appeared little prospect for successful adoption at this time.

President Holland congratulated Chris Davis for successfully completing his term as President of the CMI and announced that the CMI's next scheduled meeting will be at Montreal, Canada in June of 2023.

President Holland then reported on a request by both parties in *Douglas v. NYK*, 46 F.4<sup>th</sup> 226 (5<sup>th</sup> Cir. 2022) that the Association submit an amicus curiae brief pursuant to By-Law 702 in connection with the petition for certiorari to the U.S. Supreme Court. After considering the opinions of the Chairs of the Uniformity and Practice and Procedure Committees, the Board engaged in an extensive debate regarding the request for an amicus brief.

ON MOTION DULY MADE AND SECONDED, the Board, with one abstention, declined the requests of both parties that the Association file an amicus brief with the U.S. Supreme Court.

### VIII. FUTURE MEETINGS AND EVENTS

President Holland reported on the planning and arrangements for the Fall 2023 meeting in San Francisco from October 18-21. The Association has tentatively reserved the Argonaut Hotel in San Francisco for Members' lodging and evening events on Wednesday and Saturday, with committee meetings to be held in local law offices on Thursday and CLE on Friday. Several venues are under consideration for a reception and dinner on Friday evening. President Holland also reported on plans for the Winter 2023 Board meeting at Charleston, SC and the Summer 2023 Board meeting at Mackinac Island, MI.

In addition, President Holland reported that the Tulane Admiralty Law Institute had decided on March 20-22, 2024 for its next seminar. The ALI planners had tried to obtain an early March date that would allow coordination with the winter MLA Board meeting in 2024, but Tulane was unable to make the desired earlier dates available for the ALI seminar.

# IX. NEW BUSINESS

There was no new business proposed.

# X. ADJOURN

After thanking the Board of Directors for their service, and there being no further business of the Board of Directors of The Maritime Law Association of the United States, President Holland adjourned the meeting at 5:08 p.m.
