The total number of new members proposed for the February 24, 2024, Board Meeting is eighteen (18), comprised of thirteen (13) Associates, one (1) Judicial, one (1) reinstatement, and three (3) Law Students. In addition, two (2) Associate Members were approved for Proctor status.

ON MOTION DULY MADE AND SECONDED, the Board unanimously approved the Membership Secretary's Report.

## V. WEBSITE AND TECHNOLOGY SECRETARY'S REPORT

Website and Technology Secretary Krieger reported that the website migration has been delayed due to issues with the Standing Committees' pages, as the current MemberClicks application is inadequate to fully support the Committee pages. Secretary Krieger and Special Liaison Kevin O'Donovan are working to find a suitable platform for the Standing Committees' pages. Once the Committees' pages have been migrated to the new platform, Secretary Krieger anticipates scheduling training sessions for the Committee Chairs and Vice Chairs to ensure their familiarization and ability to properly use the new platform.

ON MOTION DULY MADE AND SECONDED, the Board unanimously approved the Website and Technology Secretary's Report.

## VI. BOARD COMMITTEE REPORTS, UPDATES

#### A. Second Vice President

Second Vice President Moseley reported on the Committee Chairs' meeting held in early February to discuss logistics and CLE topics for the Spring meeting in New York. All Standing Committee meetings for the Spring meeting will be held in midtown Manhattan for the convenience of the Associations' members, and Second Vice President Moseley assured the Board that the Standing Committees' meetings and CLE presentations will be well worth attending.

#### VII. DISCUSSION TOPICS

Past President Frank Nolan, a member of the Comité Maritime International's Executive Council, reported on the CMI's 2024 Colloquium to be held at Gothenburg, Sweden on May 22-24, 2024. Mr. Nolan provided an update on the status of the Convention on the International Effects of Judicial Sales of Ships ("Beijing Convention"), which recently received the endorsement of Liberia and will likely receive approval by the nations of the European Union at a second signing ceremony scheduled for June 19, 2024, in Malta.

Immediate Past President Dave Farrell reported on the Association's continued advocacy for adoption of the Rotterdam Rules by the United States. Given the intransience of the United States Senate regarding ratification of the Rules, the CMI may decide to move forward without the U.S. The CMI considers the 100<sup>th</sup> anniversary of ratification of the Hague Rules in 2024 as an appropriate occasion to move forward with ratification of the Rotterdam Rules. Mr. Farrell explained the critical importance of support by the American Association of Port Authorities ("AAPA") if the Rotterdam Rules are to have any chance of being ratified by the U.S. Currently, the AAPA opposes ratification because of the ports' inclusion within the Rules' definition of "maritime performing parties," and the concern of the AAPA that it will expose its members to liability for cargo losses.

Director Mark Newcomb, the Chair of the Carriage of Goods Committee, reported on the debate within that committee regarding a motion submitted by one of its members to advocate for amendment of COGSA to abolish the \$500 package limitation and legislation overturning the Supreme Court's holding in *Vimar Seguros y Reaseguros v. M/V SKY REEFER*, 515 U.S. 528 (1995). A discussion was had among the Board regarding the Association's Bylaw 504 and the procedures required before a non-unanimous motion from a Standing Committee may be acted upon at a general meeting of the members.

President Holland reported on the fine job that Vince Foley and his working group completed on behalf of the Association in which they provided written answers to the CMI's questionnaire regarding modernizing the 1910 Collision Convention.

President Holland reported on the plans of the Young Lawyers Committee to host regional CLE Seminars currently scheduled for June 6, 2024, in Norfolk, and either July or August in Long Beach. The Board authorized the Association to contribute up to \$1,500 towards the expenses of each of these YLC seminars.

First Vice President Hurley acknowledged the work of Richard Bertram and the Young Lawyers Committee on the Association's 125<sup>th</sup> anniversary project of compiling the U.S. Supreme Court's maritime decisions for the past 125 years.

## VIII. FUTURE MEETINGS AND EVENTS

Past President Clyne reported that the plans for the 125<sup>th</sup> anniversary celebration during the Spring meeting in New York from May 1-3, 2024, have been finalized. The week's festivities will kick off with a reception at Tavern on the Green on Wednesday evening, May 1<sup>st</sup>, open to all members and invited guests. On Thursday, May 2<sup>nd</sup>, there will be a dinner at the Yale Club, 50 Vanderbilt Avenue, but due to a maximum capacity of 260 persons, the dinner will be limited to members and one guest.

Director Tom Wynne reported on plans for the Summer Board Meeting to be held in Cleveland, Ohio on August 1-3, 2024.

First Vice President Hurley reported on the continuing plans for the 125<sup>th</sup> anniversary celebration during the Fall meeting in New Orleans from October 23-26, 2024. There will be a welcoming reception at the Windsor Court Hotel on Wednesday, October 23<sup>rd</sup>, for members and guests, followed by a cocktail reception on Thursday evening, October 24<sup>th</sup>, at the Southern Yacht Club. On Friday evening, October 25<sup>th</sup>, there will be a dinner at Arnaud's Restaurant in the French Quarter. The Committee meetings will be held in local law offices instead of a central location normally associated with the Fall meeting.

#### IX. NEW BUSINESS

There was no new business proposed.

#### X. ADJOURN

After thanking the Board of Directors for their service, and there being no further business of the Board of Directors of The Maritime Law Association of the United States, President Holland adjourned the meeting at 12:05 p.m.
