ANNUAL DINNER-MEETING

The *Annual Meeting* will be held in the Carter and Evarts Rooms of the Association of the Bar of the City of New York, 42 West 44th Street, New York City, on Friday, May 7, 1948, preceded by a meeting of the Executive Committee. At a later date more detailed notice will be given of the subjects to be discussed at the meeting.

The *Annual Dinner-Meeting* will be held on Friday evening, May 7, 1948, in the Belvedere Room of the Hotel Astor, Broadway and 45th Street, New York City. The Hon. Robert P. Patterson, former Secretary of War, will address the meeting. The Judges of the United States Circuit Courts of Appeal for the First, Second and Third Circuits, and of the District Courts for the Southern and Eastern Districts of New York, as well as the District Judges in New Jersey, Boston and Philadelphia, will be invited to the dinner as guests of the Association. If any member will advise the Secretary of the names of any Federal Judges from other Circuits or Districts who are likely to be in or about New York at the time of our meeting, the Association will be pleased to invite them also as guests.

The charge for the Dinner-Meeting (including tip and cocktails) is \$8.50 for members and \$11.50 for guests, who must be invited by members. Cocktails will be served at 6:45 P. M.; Dinner will be served at 7:30 P. M. Business dress only is expected.
