**FIFTY-THIRD ANNUAL MEETING**

The Fifty-Third Annual Meeting of the Association will be held at the Association of the Bar of the City of New York, 42 West 44th Street, New York City, on Friday, May 2, 1952, at 2:30 P. M., preceded by a meeting of the Executive Committee. At a later date more detailed notice will be given of the subjects to be discussed at the meeting.

The Annual Dinner Meeting, *for members only*, will be held on Friday evening, May 2, 1952, in the Grand Ballroom of the Park Lane Hotel, Park Avenue at 48th Street, New York City. The Judges of the United States Courts of Appeal for the First, Second and Third Circuits and of the District Courts for the Southern and Eastern Districts of New York, as well as the District Judges of New Jersey, Boston and Philadelphia, will be invited to the dinner as guests of the Association.
