Reservations will only be made when payment has been received. Refunds will not apply to cancellations received after October 26, 1970, nor can requests for seating changes be entertained after that date.

Visiting members may register at the registration desk which will be maintained at the Mark Hopkins Hotel from noon until 5:00 p.m. Thursday, October 29, 1970 and from 9:00 a.m. until 5:00 p.m. Friday, October 30, 1970. All visiting members are requested to register as promptly as possible after arrival. Wives of some of the San Francisco members of the West Coast Committee will be

on hand both at the reception desk and on the cruise and luncheon on Friday and will, of course, try to answer any questions. There will also be available at the registration desk printed information on things and places of interest in San Francisco, how to get there, and how the most can be seen by walking or by bus.
